- Major Comments
 - Too long!!
 - > DVD was approx. 10-mins. (need to shorten by 2-3 mins.)
 - Tighten-up/shorten ending credits
 - Shorten the CCITS "problem statement" footage at the beginning or eliminate duplicate message at the end
 - Shorten Caltrans D5 TMC footage (somewhat repetitive)
 - Shorten/replace CCITS Coordinating Group footage
 - Additional Footage
 - "Who" is to provide footage??
 - Caltrans Film Crew may be able to provide SB & SC footage
 - > If not Caltrans, individual Agencies will need to provide footage
 - ACTION ITEM CCITS Coordinating Group to provide additional filming timeframe to Caltrans by COB 11/17/06 & AMBAG to follow-up with Caltrans External Affairs Unit Manager re: scheduling Regional Agencies footage
 - > SBCAG

 - > As available, will provide FSP benefits values (\$\$, %, etc.)

 - Wants footage re: inside bus NextStop Annunciation System
 - > Delete footage re: SC Boardwalk Parking Management System

 - Actual ITS Projects throughout Central Coast (Need ideas/input from EVERY CCITS Agency)

 - > Better distinction between "actual" ITS Projects vs. "planned:
 - ➢ Slide #3 − Add "TAMC"
 - Slide #15 (ITS Benefits per se) Move more to the front
 - Slide #16 Remove "CMAQ"
 - Slide #16 Replace TEA-21 w/ FHWA-provided language
 - Too detailed/too much information
 - > Use bigger font (24-28 minimum size)
 - > Delete "AMBAG" watermark from left-hand side

2. CCITS WEBSITE

- Iteris to see if they can post the CCITS DVD/Video to the website to assist in the Agency review process
- Caltrans D5 investigating whether or not they have the capability to host the CCITS website after the project is competed (Caltrans, AMBAG, & Iteris to discuss)
- Discussion re: the potential to add the CCITS Turbo Arch databases (each of the 3 MPOs) to the CCITS Website
 - IDEA #1 Provide interactive capabilities via HTML or VB Script
 - Iteris demoed the Southern Nevada website
 - CCITS Coordinating Group liked the website but thought that it was "too much" right now for the Central Coast
 - IDEA #2 Post PDFs (reports, diagrams, etc.) on website for view/download
 - CCITS Coordinating Group will more realistically look into this option
 - Website hosting options potentially include: Caltrans, AMBAG, each individual MPO, or a CCITS Group-sponsored website

3. ARCHITECTURE MAINTENANCE PLAN

- DONE CCITS Coordinating Group approved the CCITS Architecture Maintenance Plan (FINAL)
- FINAL will reference that each MPO will coordinate changes to their own Turbo Architecture database and conduct quarterly meetings with each other to review SERFs and implement changes to their own database

- To avoid confusion, this document has been re-named the "CCITS Architecture Usage Guide" (from the CCITS Architecture Implementation Plan)
- Document Direction
 - CCITS Coordinating Group wants to "hold-off" on providing detailed comments on the DRAFT until Turbo Architecture "shadow" training is provided
- User Guide
 - FHWA developed/distributed "Overview of Federal Funding & Oversight of ITS Projects"
 - TransCore to coordinate its contents with the "CCITS Implementation Plan"

7. TURBO ARCHITECTURE "SHADOW" TRAINING

- 1st Priority
 - Iteris provides separate "hands-on/one-on-one" training to each of the 3 MPOs
 - > MPOs believe that 6-hrs of training is adequate
 - > MPOs need to determine "when" exactly they want training
 - ACTION ITEM Iteris to develop script/agenda/outline by COB Fri <u>12/1/06</u>
- 2nd Priority
 - As funding is available through the training line item or thru use of CCITS Technical Support funds, might want to offer additional 2-hour training sessions for Local Agencies and/or special topics
 - Training re: "how" to access specific Turbo reports, diagrams (e.g., adding stakeholders, changing systems, market packages and/or interconnects, etc.)
 - > Training re: "how" to fill-out/complete a SERF and/or SEMP
