## 2. CCITS WEBSITE (DONE)

- CCITS Website

  - AMBAG has offered to "host" the CCITS website (based on requirements per Iteris' e-mail & Group discussion)
  - Iteris to continue to host/clean-up CCITS website until website files submitted to AMBAG
  - Iteris to provide all CCITS website HTML files to AMBAG (at end of CCITS Project)
- Iteris offered to place PDF/HTML pages of the CCITS Architecture on the CCITS website
  - Just snapshot of Turbo database files as submitted at the end of the project (static)
  - Not dynamic update to website based on Turbo file modifications (dynamic is more what the Group wants though)

### 3. TURBO ARCHITECTURE "SHADOW" TRAINING (DONE)

- Iteris provided/completed training Feb '07 (AMBAG, SLOCOG, & SBCAG)
- Discussed Iteris' remaining budget (~\$3,300)
  - SBCAG wants Iteris to review their next Turbo Architecture update (2-3 years out though)
  - SCCRTC wants access to/insight into all/other ITS Projects throughout the State (in order to incorporate/identify applicable ITS Projects for Santa Cruz)
  - AMBAG noted that the CCITS Project ends 12/31/07 so that folks need to identify near-term items for Iteris to complete

  - TransCore to submit FINAL Turbo Databases on CD-ROM to AMBAG, SLOCOG, & SBCAG
- Turbo Reports
  - One (1) PDF file copy of each to AMBAG, SCCRTC, SBtCOG, TAMC, SLOCOG, & SBCAG
    - All Turbo-generated reports (System Inventory, Concept-of-Operations, Functional Requirements, Market Packages, & ITS Standards)

  - Group Question "...What action(s) are needed from the County Boards to achieve FHWA Requirements??..."
  - ➤ FHWA Response "...Acknowledgement re: ITS Project planning and/or ITS Architecture efforts already accomplished..."
  - FHWA Response "...Commitment to adding/integrating ITS w/in the Regional Transportation Improvement Plan and/or funding commitments..."
- Document
  - On cover, just "Fall 2007" (no DRAFT, FINAL, etc.)
  - Once "final" direction received, TransCore to submit FINAL document w/in 3-weeks
  - TransCore to send "track-changes" version of FINAL document to AMBAG for review prior to document production

  - Make document more user-friendly
  - Pose questions/get readers to the correct section(s)
  - ➤ Bullet point description re: sections and/or graphics depicting such processes, approaches, etc.

    - SCCRTC to send sample/descriptive "table-of-contents vs. reader's-point-of-view"
    - Caltrans D5 to send "Statewide ITS Architecture" sample guide (DONE)
    - Once all samples/ideas are submitted, TransCore to develop CCITS implementation Plan "road map & submit to Group to finalize (Kathy, Mike, James, Tim, Grace, & Frank)

## 7. TASK D3 - ITS PROJECT LOG (UPDATE) & METHODOLOGY

- Gathered input re: what the CCITS Coordinating Group really wanted to accomplish w/ this task, what would be a useful product/end-result, etc.
- Discussed TransCore's "recommended approach" (separate 5-page handout)
- CCITS Coordinating Group determined that they will proceed using TransCore's approach
  - Caltrans D5 to complete their ITS Project Log on a monthly basis
  - All other Agencies to complete their ITS Project Log on a quarterly basis
  - Add the following columns to "Sample Format ITS Project Log"
    - Inter-Agency Project (Y/N entry)
    - County-Specific Project (Y/N entry)
    - Project Cost
    - Comments
  - Create ITS Project Log using Excel spreadsheet
  - For completed/implemented ITS Project, Agency to start/indicate such using separate entries/rows/list at bottom of ITS Project Log
  - Delete "No./Number" column as Agencies just want to "infer" ITS Project priorities

## 8. TASK D4 – COLLABORATIVE PROJECTS PROTOCOL

- Per TransCore's recommended approach, Task #'s D3 & D4 will be conducted/performed together due to the collaborative nature of their intent/deliverables
- All comments per Task D4 are included w/in Task D3 (per above)

#### 9. CENTRAL COAST - NEXT STEPS

- Discussed next steps re: "how" the CCITS Coordinating Group (Planning Group) & the CCITS Implementation Group (Technical Group) will proceed
  - Determined that the typical roles & responsibilities of the CCITS Implementation Group will be the same as the CCITS Coordinating Group (aka basically a name change)
  - ➤ Each Agency then to invite "ITS Experts" from their Agency and/or County to attend CCITS meetings (as necessary/applicable)
  - ➤ AMBAG will continue to lead the CCITS Implementation Group
  - CCITS implementation Group meetings to be bi-annual (2x per year), unless more frequently needed
- Discussed CCITS "Action Plan (Exhibit 6.2, CCITS Implementation Plan DRAFT)
  - NO...Do not add "CCITS Implementation Group" column (per Caltrans D5 request)
  - YES...Add typical roles & responsibilities from Task D3 (per above)
  - > YES...Add typical roles & responsibilities from Task D4 (per above)
