## 1.0 Background

The Federal Highway Administration (FHWA), the Nebraska Department of Roads (NDOR), Lancaster County, and the City of Lincoln have sponsored development of a Regional Intelligent Transportation System (ITS) Architecture for Southeast Nebraska (SENEARCH). The goal of the architecture is to answer questions such as:

- How can we make travel on our highways safe, secure and more efficient?
- How can we make government services, such as transit and emergency response, more efficient?
- What can we do working together, that we can't do as well on our own?

The SENARCH will become a plan of projects for technologies, interagency collaboration, communication and technical integration in the 13-county Southeast Nebraska region. The plan is required by the Federal Highway Administration and the Federal Transit Administration to illustrate and document regional integration so that planning and deployment of ITS solutions can take place in an organized and coordinated fashion throughout Southeast Nebraska to improve transportation safety, efficiency, and security. FHWA and good practice require involvement of multiple stakeholders as the plan is being developed. The Stakeholder Outreach Plan creates the framework and process for identification and involvement of stakeholders in the development of the Regional ITS Architecture for Southeast Nebraska.

#### 2.0 The Study Process

The overall purpose of the Stakeholder Outreach program is to involve key agencies in identifying potential applications of ITS technology in their respective jurisdictions. The many benefits of Intelligent Transportation Systems will best be realized by effectively involving key stakeholders. Local representatives of law enforcement, health agencies, private business/organizations and departments of transportation all have specific knowledge of the strengths and weaknesses of the current systems.


The Southeast Nebraska Regional ITS Architecture is being prepared under the guidance of a Project Steering Committee. The steering committee includes representatives from the four sponsoring agencies and other key stakeholders. The steering committee has engaged the services of a consulting engineering team. The Iteris Team is comprised of Iteris, Inc. as the prime contractor with Olsson Associates, and TranSmart Technologies to assist with development of the plan. The process follows procedures in the FHWA document entitled: "Regional ITS Architecture Guidance."

#### 3.0 The Region

The first step in the ITS planning process is to define the "region" that the plan will cover. The Southeast Nebraska Regional ITS Architecture will encompass all communities and interested organizations within the following 13 counties in Southeast Nebraska: Butler, Saunders, Seward, Lancaster, Cass, Otoe, Saline, Gage, Johnson, Nemaha, Jefferson, Pawnee and Richardson. Figure 1 on the following page provides a map of the Southeast Nebraska Region. This region is the same as the Nebraska Department of Road's District 1 boundary.

#### 4.0 Additional ITS Planning Efforts

The Nebraska Department of Roads has recently completed the "Statewide ITS Architecture." The NDOR plan identifies systems and technologies that will be implemented statewide primarily at the state level (NDOR, Nebraska State Patrol, Nebraska Emergency Management Agency, etc.). The NDOR plan also identified some coordination and connectivity to systems within local jurisdictions but does not describe how local jurisdictions become involved in ITS.

The Omaha-Council Bluffs Metropolitan Area Planning Agency (MAPA) is creating a similar plan for the agencies within the MAPA boundaries in both Nebraska and Iowa. Development of the Southeast Nebraska Regional ITS Architecture is being coordinated with the Statewide ITS Architecture and the MAPA Regional ITS Architecture.

The Southeast Nebraska Regional ITS Architecture will coordinate with both these to ensure common nomenclature is used throughout the process, while making sure that the proper connections are included within both of the regional ITS architectures.

#### 5.0 Identification of Stakeholders and ITS Champions

The steering committee identified broad categories of stakeholders. These stakeholders include representatives from the categories shown in the following table:

Detailed lists of stakeholders and contact information are being maintained in Appendix A. Appendix A will be a "living" document, updated throughout the study. This plan and Appendix A will be maintained on the project website.

Stakeholders can elect to be involved in several ways. Some may be content to receive information and project updates. Others will be involved in more direct ways by attending some of the project meetings and workshops. Finally, some may take on the role of ITS "Champion." These Champions will have a more active role and provide more input and direction to the study along with the sponsoring agencies. Some stakeholders will become actively involved throughout the plan and will be part of the project Memorandum of Understanding. The Memorandum of Understanding will move the plan elements forward to implementation and operations. Champions who are interested could be added to the steering committee.

#### 5.1 Initial Stakeholder Contact

Throughout the course of the Southeast Nebraska Regional ITS Architecture a number of different methods on communication and contact will take place with the Project Steering Committee and project stakeholders. These methods are described in more detail below.

- **5.1.1 Phone Calls**: Initial stakeholder contact is designed to be efficient and effective. Initial contact will occur over a very short time frame at the study's inception. Initial contact will occur by phone. E-mail will be used for follow-up. The personal phone contact will allow the project team to effectively manage and document the results of the initial contact effort.
- **5.1.2 Talking Points:** Since several people will be making the initial stakeholder calls, a talking points document has been prepared. The talking points document will ensure that stakeholders receive the appropriate messages and invitations to be part of the study effort. The talking points document is included in Appendix B.

The intent of the initial phone contacts is to:

- Describe the ITS study
- Convey a genuine interest in the involvement and input of each stakeholder
- Update the stakeholder list for needed modifications / additions
- Request opportunities to present study objectives at local meetings

#### 5.2 Initial Stakeholder Input:

The second step in the regional ITS planning process is to develop an understanding of what stakeholders are doing today and an understanding of stakeholder transportation needs that can be addressed by intelligent systems and technology. For those stakeholders with an active interest in the planning effort, the Project Team will initiate a follow-up meeting. The follow-up meeting will have several specific objectives.

- Answering stakeholder questions
- Learning about the stakeholders' existing, planned and futuristic systems and technologies.
- Learning about stakeholder transportation safety, efficiency and security needs.

**Database:** The Project Team has created a stakeholder outreach and interaction management database. The database will be used to plan and manage the extensive stakeholder outreach effort. The database will be used to provide periodic reports to the steering committee on the status and results of the initial stakeholder contact efforts and follow up.

To the extent possible, this round of stakeholder input will be completed in time to be reported (Inventory Report) and discussed at the Stakeholder Workshop #1.

# 5.3 On-Going Stakeholder Interaction:

All subsequent steps of the ITS planning process require on-going involvement of appropriate stakeholders. But not all stakeholders will require on-going interaction at the same levels. The Stakeholder Outreach Plan includes several methods to maintain on-going interaction with stakeholders:

**5.3.1 Project Website:** A project website will be developed at the beginning of the project. The website will be the primary tool for providing basic information on ITS and on the study process to stakeholders. The website will be the primary tool for keeping stakeholders informed about study progress and outcome. With each stakeholder contact, the website and address will be promoted. It is the intention of the steering committee that their respective agencies will create a link to the project website. It is also the intent of the steering committee that a lead agency will agree to maintain the website after the study is complete to promote regional collaboration during on-going efforts to implement the Southeast Nebraska Regional ITS Architecture. The website address is www.iteris.com/senearch.

In addition to the presentation of information, project stakeholders will also be able to communicate with the consultant team via a "contact us". This feature will allow the stakeholders to send emails to the project team. The recipient of these emails will be both the Project Manager, Marc Porter, as well as the Deputy Project Manager, Mike Malone. They will, in turn, forward any pertinent information to both the City's Project Director, Virendra Singh and other team members as appropriate.








Figure 2: Typical Logos for SE **Nebraska Regional ITS Architecture**

**5.3.2 Project Logo:** A project logo will be developed. The logo will be designed to depict the Southeast Nebraska region and stakeholders. The logo will be displayed on the project website and on all official correspondence, products, and reports produced by the Project Team. Figure 2, on the following page, shows an example logo. The Project Steering Committee will approve the final logo.

- 5.3.3 Project Updates: The Project Team will develop a Project Update at key points throughout the study. The update will document project progress and outcomes. Electronic copies of the update will be posted on the project website and e-mailed to interested stakeholders.
- 5.3.4 Stakeholder Workshops: A series of four Stakeholder workshops will be scheduled during the study. Each workshop will cover specific steps in the ITS planning process. Planned workshops for this study are outlined below:
  - Workshop #1: ITS education, systems and needs inventories, operational concepts, and interagency communication networks and technologies
  - Workshop #2: System and technology interfaces, projects and project sequencing
  - Workshop #3: Interagency agreements, system and technology standards, and maintaining and updating the ITS plan
  - Workshop #4: Presentation of the Southeast Nebraska Regional ITS Architecture

Each workshop will have multiple purposes such as:

- Updating attendees on progress and results to date.
- Gathering information and input from stakeholders about results to date and for future steps.
- Providing stakeholders with the opportunity to network with each other (this is a secondary benefit of workshops of multiple stakeholders and often creates momentum for future study efforts and on-going project implementation after the study concludes).

Each workshop will be between two to three hours in duration. A typical agenda for each workshop will include:

- Welcome and Introductions
- Opening Presentation focusing on key themes of the workshop
- Stakeholder Comments opportunity for stakeholder questions and input on workshop topics. This session could also include stakeholder prioritization of ITS services for the region.
- Workshop Summary and Next Steps the project team will summarize the workshop comments and inform stakeholders about next opportunities to provide input.

- **5.3.5 Supplemental Stakeholder Meetings:** Additional stakeholder meetings are planned between workshops. These meetings may be with individual stakeholders or small groups of stakeholders. These meetings could be conducted in person or by conference telephone call or in some combination of the two methods. The purposes of these meetings are to:
  - Gain input from key stakeholders who were not able to attend the previous workshop.
  - Gain more detailed information on specific study elements.
  - Promote interagency collaboration and cooperation leading to system and/or project related letters of intent to cooperate, memoranda of agreement, and/or interagency agreements.

**5.3.6 Post-Study Meetings and Presentations:** After Workshop #4 and after approval of the Southeast Nebraska Regional ITS Architecture by the steering committee, the Project Team, steering committee members, and regional ITS Champions will meet with key stakeholders and decision-making bodies. Since the goal of the study is to pave the way for ITS implementation to improve transportation safety, efficiency and security, these presentations and meetings will be designed to promote acceptance or adoption of the plan by key decision-makers and funding authorities. Acceptance and adoption of the plan by multiple regional agencies will create momentum for future project agreements, design, implementation, and on-going operations and maintenance.
